- Offset Pole Bands are used for dead-ending, guying, and mounting secondary racks on metal poles, pipe masts, or conduit.
- Each Pole Band Assembly contains two 1/4" x 1-1/2" stamped brackets, two 1/2" x 2" Carriage Bolts with Regular Square Nuts for clamping brackets together, and one 5/8" x 2" Carriage Bolt with Regular Square Nut for attaching racks.
- All components are hot dip galvanized to meet ASTM Specification A153.

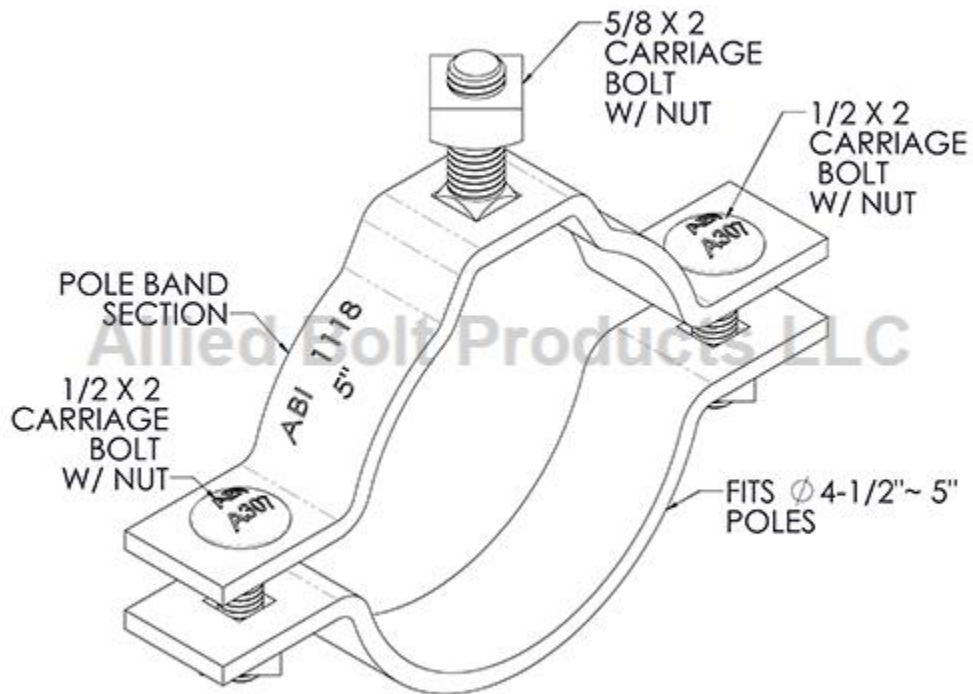
