- Manufactured from AISI 1016 Steel.
- Saw slotted for deep even groove.
- All sizes are fully threaded.
- Zinc plated to meet ASTM Specification F1941.
- Screws conform to the dimensions of ASME B18.6.3

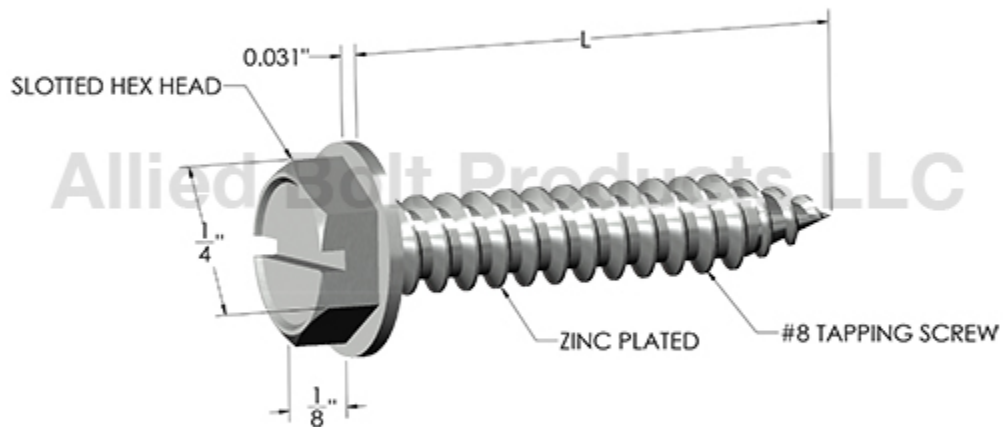
