**#8 X 1" PHILLIP MODIFIED TRUSS HEAD
SELF-PIERCING SCREW ZINC PLATED**

#1914

- Self-piercing screws feature a lead-thread that is rolled to the very tip of the screw point and then rapidly develops into a logarithmic helix for easily penetrating sheet metal.
- Perfectly molded threads reduce driving torque and strip-out problems, while contrastingly increasing the speed of installation.
- Used to "tap" their own mating internal thread when driven into wood and metallic materials.
- Does not require a pre-drilled pilot hole in sheet metal under .040" thick.
- Extra sharp point to ease starting.
- Case hardened so surface after tempering is equal to minimum Rockwell Hardness of C28-38.
- Zinc Plated to meet ASTM Specification F1941.
- Screws conform to the dimensions of ASME B18.6.3

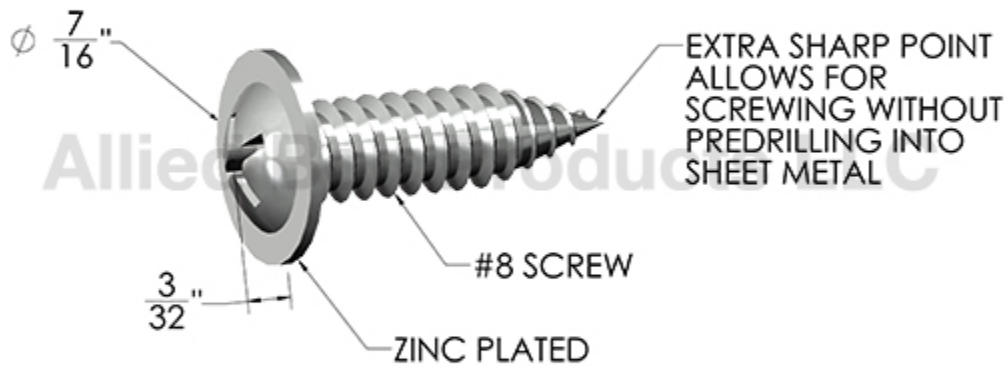
