- Standard color is black. Other colors are available by request.

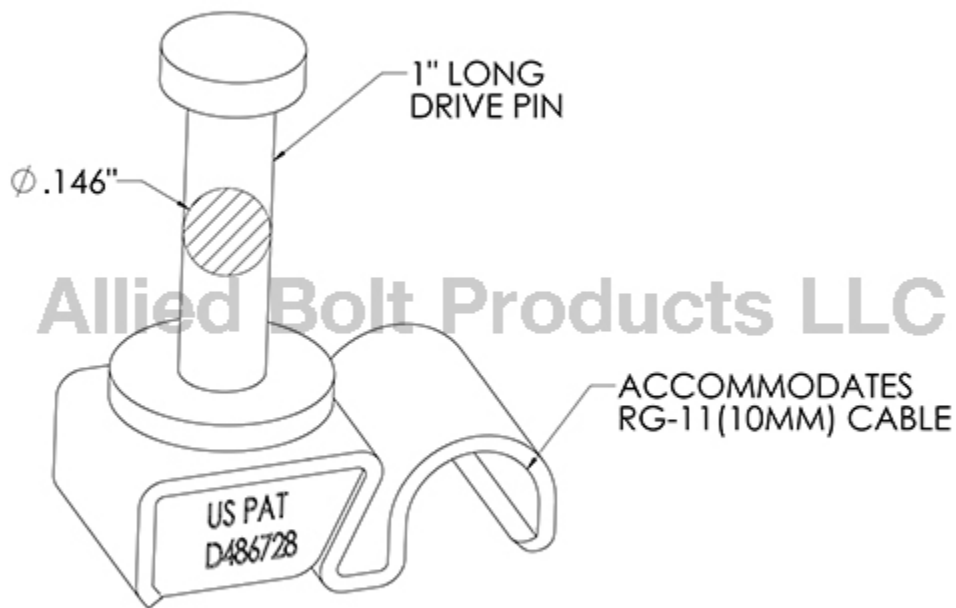
