**1/2" X 6' COPPER BONDED GROUND
ROD**

- Used as a grounding electrode for buildings and utility poles.
- Manufactured from AISI 1035 Steel.
- Copper is electrically bonded to the entire length of the rod.
- Size of rod, manufacturers mark, and appropriate testing requirement (i.e.: UL Listed) is stamped near the end of each rod for easy identification.
- Steel is drawn before plating for strength and consistency.
- Rod ends are chamfered to prevent "mushrooming" while driving and allows ground clamp to slip over rod after installation.
- Rods that are UL Listed are covered by file number E211717.

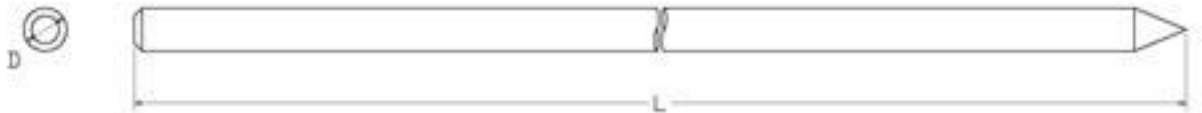
