- UL Listed for direct burial under file number E211717.

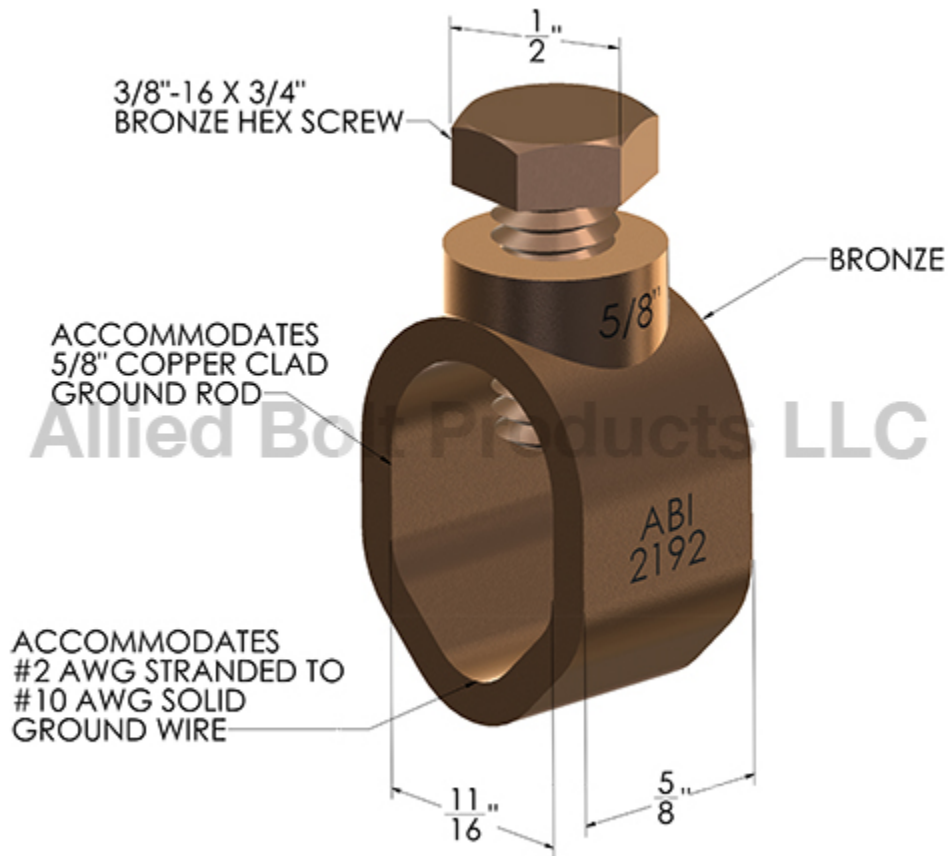
