

- Unique patented design eliminates the need to remove any hardware for installation.
- Raised projections on Strap help penetrate paint and corrosion to form a metal to metal bond. These raised projections eliminate the time consuming task of sanding the surface of the electrode before installing Strap.
- Tab (flapper) is formed with two thicknesses of material, at the end of the Strap, to protect electrode from being punctured during installation.
- Strap is stamped from 5/8" x .024" material stock. By using a larger stock size, Premium Ground Straps provide more surface contact for better conductivity.
- Galvanized Straps are manufactured from G90 Pre-galvanized Steel.
- Hardware is manufactured from pure brass. Hardware for galvanized straps is nickel plated to prevent dissimilar metals from contacting each other.
