- Screws conform to the dimensions of IFI-113.

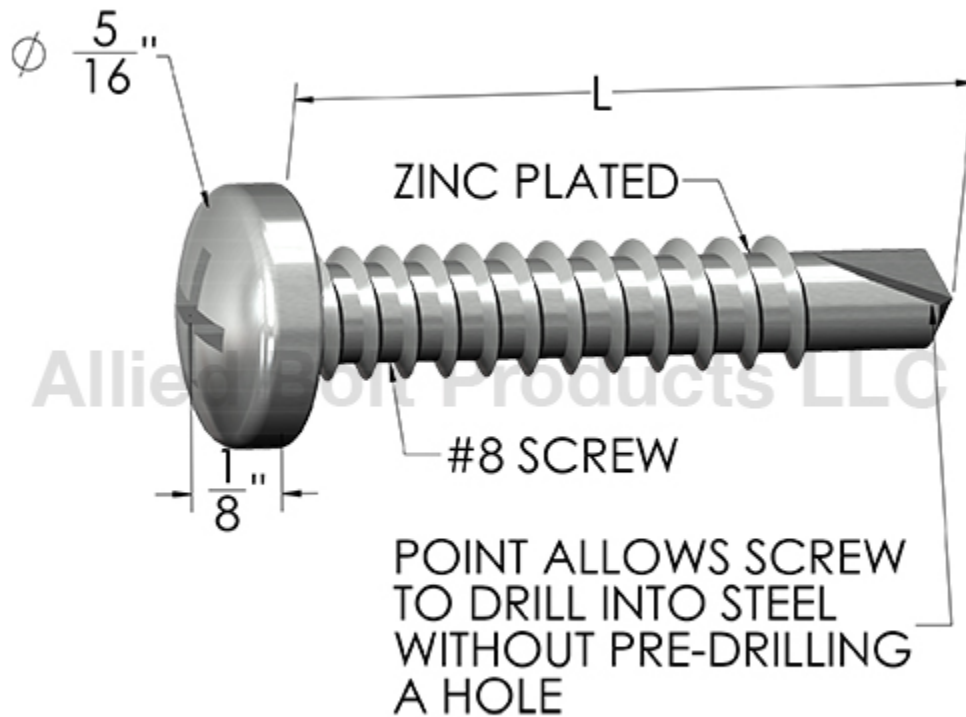
