- Nail point to help guide anchor.
- Standard head style is with a slotted hex washer.
- Manufactured from AISI 1022 Hardened Steel.
- Epoxy resin coating meets ASTM B117.
- Each box of 100 comes equipped with one 3/16" x 4-1/2" drill bit.
