- Toll required for installation.

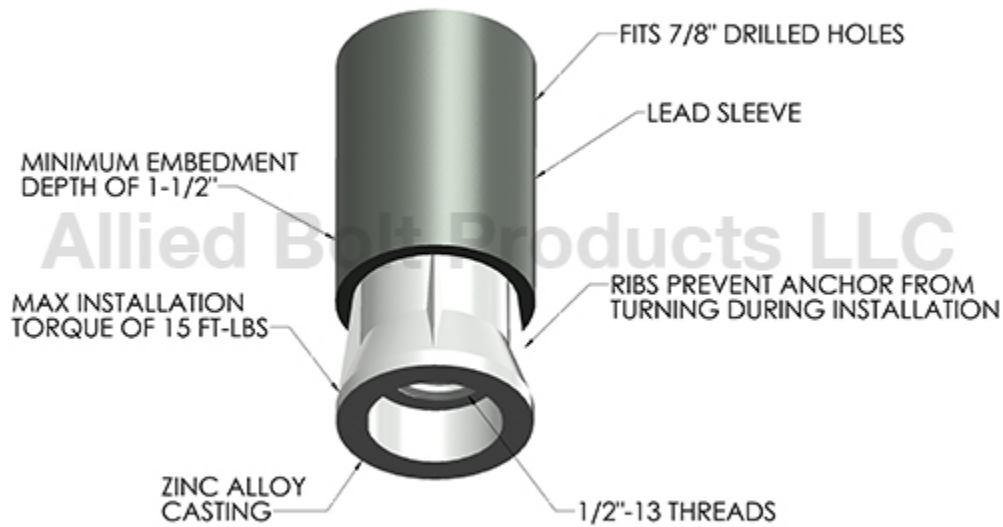
