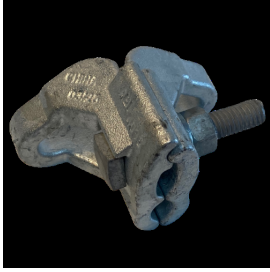

**MID-SPAN TAKE OFF CLAMP**

**#4095**

- Used to drop cable installations as an attachment to 1/0 - 4/0 ASCR for accepting the bail of Drop Wire Clamps.
- Clamp is comprised of a set of two jaws with openings to attach bail wires, square head bolt, lock washer, and a hex nut.
- Bolt and nut are formed from Grade 2 Steel.
- Jaws are forged from 1045 high strength steel.
- Bolt is hot dip galvanized to meet ASTM Specification F2329.
- Jaws, nut, and lock washer are hot dip galvanized to meet ASTM Specification A153.

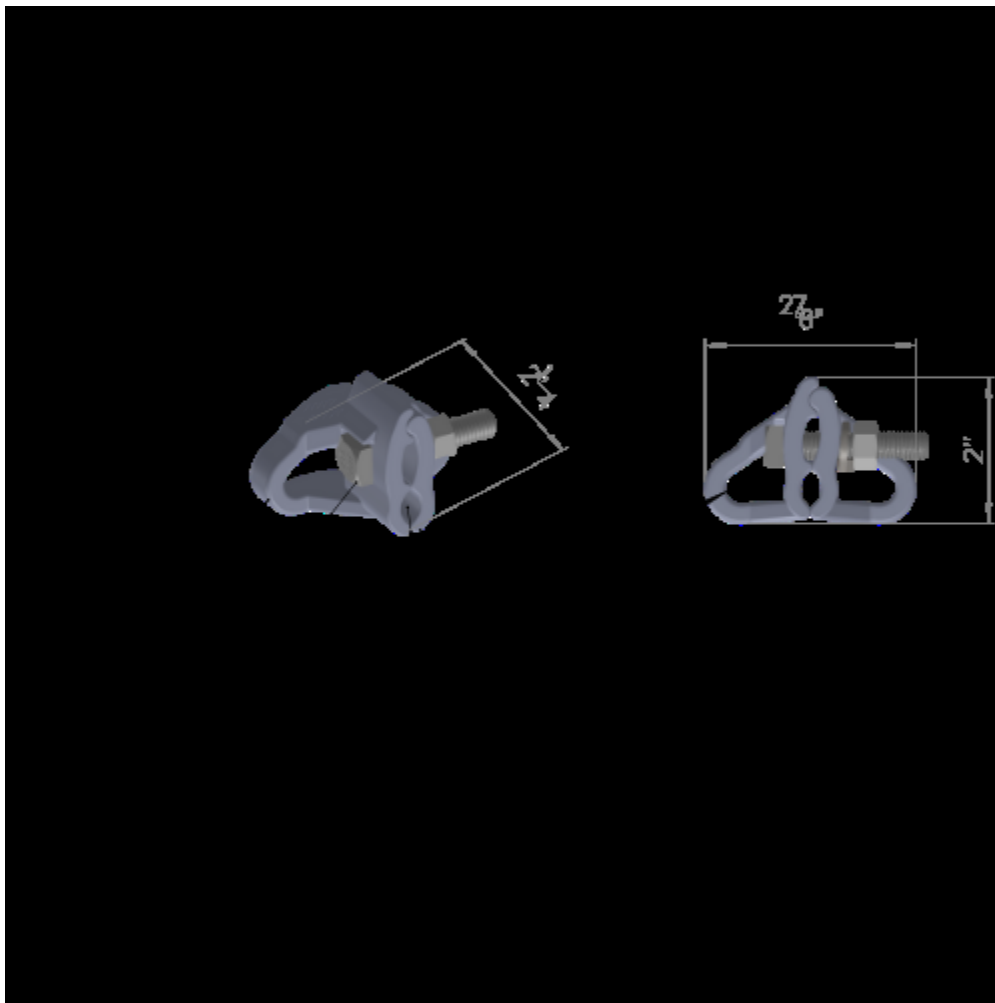
