- Hot Dip Galvanized per ASTM Specification A153.

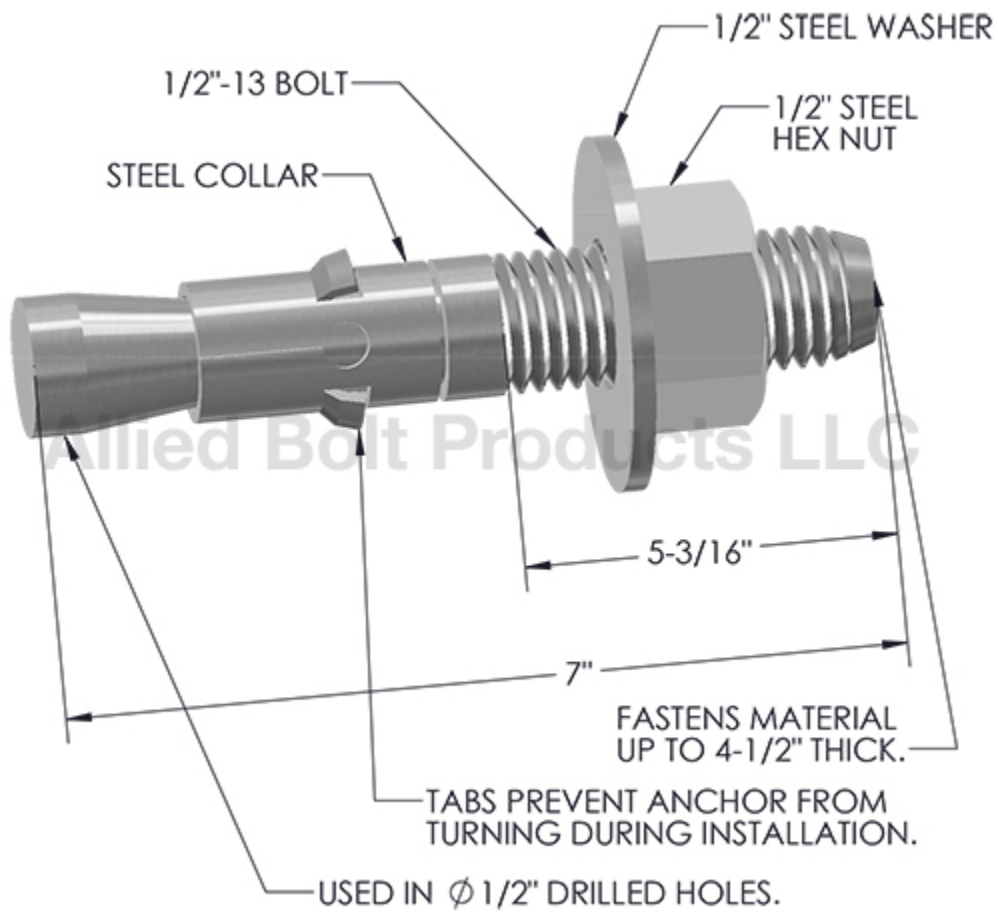
