- Dimensions conform to ASME B18.2.1.

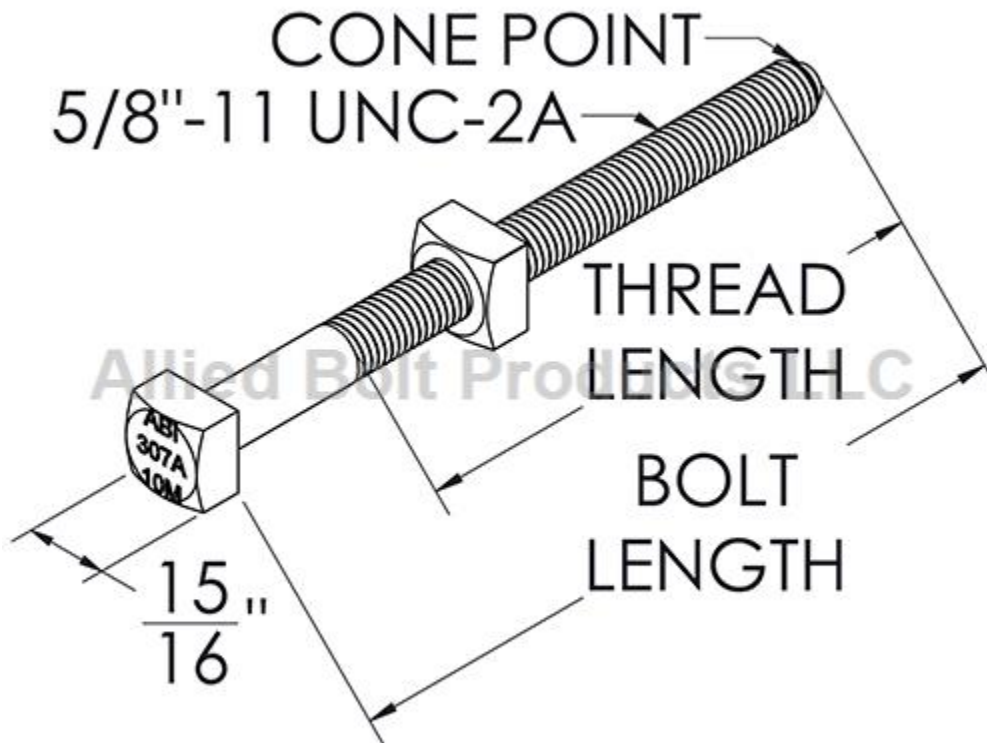
