## 1/4" X 1-1/2" B PLASTIC ANCHOR (FLAT HEAD)

- Used for making medium weight (under 100 lbs.) attachments such as clamps to all types of masonry.
- Comprised of a nylon body and a steel nail with a slotted head.
- Nails have a threaded shank and slotted head to aid in removal.
- Hole size is 1/4".
- Anchors have a flat head body.

 $\bullet$  Two longitudinal slots are formed on the working end of anchor to allow each half of the body to expand.

- Nails are manufactured from AISI 1008 Steel.
- Nails are zinc-plated to meet ASTM Specification F1941.
- Not recommended in overhead applications.


