- The clips are designed to be extremely impact-resistant.

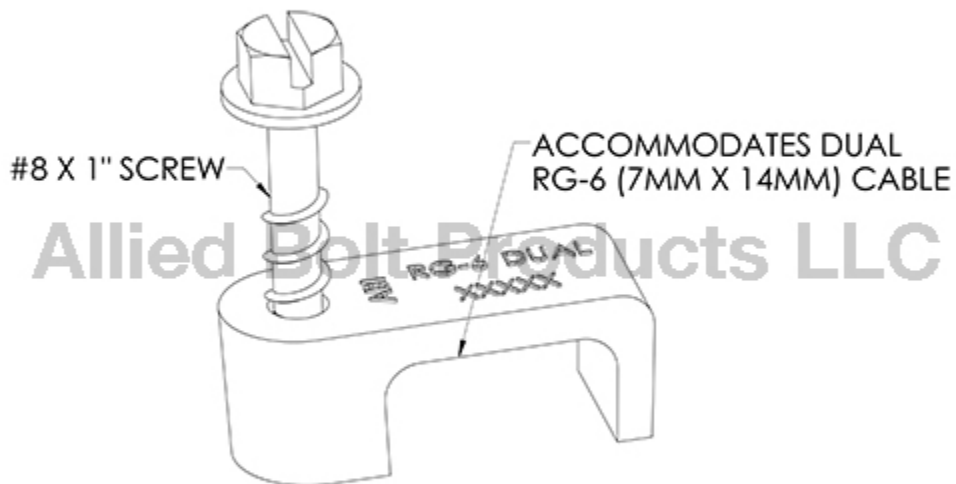
