- Used to secure jacketed strand or self-supporting cable to telephone poles.
- Each clamp is comprised of two steel plates having an oval hole in the center and a serpentine groove.
- Clamp is equipped with two track bolts and two regular square nuts.
- Manufactured from Ductile Iron.
- May be used on in-line poles and at corners with a pull of 25 or less.
- Installed without slitting the web of the cable.
- The center hole is provided for use with a 5/8" diameter cable suspension bolt.
- All components are hot dip galvanized to meet ASTM Specification A153.

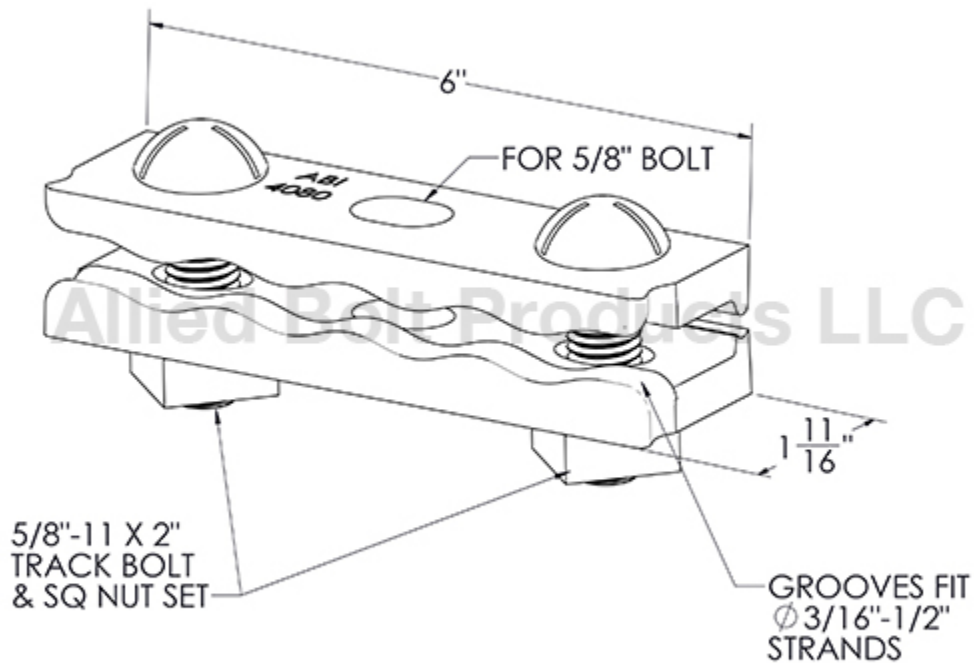
